

NRS 332.065 requires government agencies to award Bids to the lowest responsive and responsible vendor and states proposals may be judged on price, conformance to specifications, qualifications, quality and other factors. The Nevada Government E-Marketplace (NGEM) website conducts a “Bid Tabulation” (attached), that automatically calculates and sorts submissions by lowest cost. Using that document, requesting agencies then review submissions from lowest price to highest, using the factors outlined in the NRS, to determine who the responsible vendor is.

Below is a synopsis of the 4 submissions the City received from lowest to highest price:
Note: The price is a summation of all 14 line items we requested prices for.

ASAW LLC	\$325,825.00	Not Selected (No 5% Bidders Preference)
Acme Underground	\$328,682.50	Selected (Has 5% Bidders Preference)
Mountain Pine	\$331,530.00	Not Selected
CG&B Enterprises	\$436,628.00	Not Selected

NOTE: ASAW and Acme Underground were within 5% of each other’s cost, however ASAW has no Bidders Preference as defined by the NRS. Taking that preference into account, Acme Underground is the lowest responsive and responsible respondent. This Recommendation of Award is effective when the City Council Minutes are published.
