**SUBJECT:**

For possible action: Resolution No. 7590, a resolution of the City Council of Boulder City, Nevada, reallocating American Rescue Plan Act funding in the amount of \$70,000 from PPE and Vaccine purposes and to be reallocated to the Boulder City Museum and Historical Association for record digitization and historical resource rehabilitation

**Business Impact Statement:**

This action will not have a significant economic impact on business and will not directly restrict the formation, operation, or expansion of a business.

**Action Requested:**

That the City Council approve the resolution and reallocate ARPA funding from the PPE and Vaccination program to the Boulder City Museum and Historical Association for record digitization and historical resource rehabilitation in the amount of \$70,000.

**Overview:**

- The City has underutilized funds previously designated for PPE and Vaccine deployment.
- The Boulder City Museum and Historical Association are requesting funds to perform two important preservation activities.
- Total amount of funding requested is \$70,000.

**Background Information:**

The City had previously allocated American Rescue Plan Act funding for a wide variety of eligible activities, including funding the purchase of additional personal protective equipment ("PPE") and the deployment of COVID-19 vaccines and testing kits. The City has unused funds that were designated for these two activities that can be

reallocated toward other eligible uses.

The Boulder City Museum and Historical Association have approached the City with a request to receive ARPA funding for the following purposes:

Digitization of the extensive museum collection. The primary purposes for this activity is three-fold: to reduce the handling of materials and artifacts, increase access to the materials by posting the material online, and to improve efficiency and reduce time to research historical artifacts. The funding for this effort is \$50,000.

Rehabilitate the historical home owned by the Museum located at 640 Avenue C. The home was one of the first homes constructed by Six Companies for use by their employees. According to the Nevada State Historic Preservation Office, the home retains its original form and massing, and most of the historic fabric remains intact – it retains the integrity of location, design, feeling, association, and setting. The home is in need of rehabilitation to assist in the preservation of the structure as an enduring testimony to the men and women who built the dam and established Boulder City as a community. The funding for this effort is \$20,000.

Traditionally, the Museum would use its own resources to fund activities such as these. However, during the economic downturn during the Pandemic, the Museum did not realize approximately \$203,243 dollars in revenue that it would have normally generated (based on past and current performance). The Museum is seeking funding from the City's portion of ARPA funds to help them further their mission.

Financial:

There are unused funds previously appropriated under Resolution No. 7481 designated for PPE purchase and the deployment of vaccines and Covid 19 test kits that can be reallocated towards this project.

Boulder City Strategic Plan Goal:

Goal A: Achieve Prudent Financial Stewardship

Department Recommendation: Approve Resolution No. 7590, reallocating American Rescue Plan Act funds previously designated for Personal Protective Equipment and deployment of Vaccines and COVID19 test kits to the Boulder City Museum and Historical Association for the digitization of historical records and the rehabilitation of a historical resource in the total amount of \$70,000.
