SUBJECT:

For possible action: Resolution No. 7799, a resolution of the City Council of Boulder City, Nevada, approving Agreement No. 24-2085 (Interlocal Contract 3136) between the Regional Transportation Commission of Southern Nevada and the City of Boulder City, Clark County, and the Cities of Henderson, Las Vegas, Mesquite, and North Las Vegas for the Work Zone Management – One.Network project in the amount of \$350,000.00

Business Impact Statement:

This action will not have a significant economic impact on business and will not directly restrict the formation, operation, or expansion of a business.

Action Requested:

That the City Council approve the resolution, approving the agreement (Interlocal Contract 3136) between the Regional Transportation Commission of Southern Nevada and the City of Boulder City, Clark County, and the Cities of Henderson, Las Vegas, Mesquite, and North Las Vegas for the Work Zone Management – One.Network project in the amount of \$350,000.00.

Overview:

- An interlocal contract is required in coordination with City of Boulder City, Clark County, and the Cities of Henderson, Las Vegas, Mesquite, and North Las Vegas for funding from the Highway Improvements Acquisition Fund to be used for the Work Zone Management – One.Network project.

Background Information:

The Regional Transportation Commission of Southern Nevada (RTC) approved funding for the Work Zone Management – One.Network project which consists of a regional strategic plan for work zone coordination, which is an initiative that aims to improve public messaging and response in real time to construction impacts on transit and traffic management operations throughout Clark County. The RTC is going to engage in a pilot project with One.Network, which will be managed by the Freeway and Arterial System of Transportation (FAST). If the pilot project is successful, FAST will coordinate with other agencies to incorporate this messaging system into their jurisdictions.

Funding for this project will come from the RTC's Highway Improvement Acquisition Fund – Fuel Revenue Indexing for Fiscal Year 2024 in the amount of \$350,000.00. An interlocal contract is required in coordination with Clark County, City of Las Vegas, City of North Las Vegas, City of Henderson, and City of Boulder City for funding from the Highway Improvements Acquisition Fund to be used for the project.

Department Recommendation: The Public Works Department respectfully requests that the City Council approve Resolution No. 7799, approving Agreement No. 24-2085 (Interlocal Contract 3136) between the Regional Transportation Commission of Southern Nevada and the City of Boulder City, Clark County, and the Cities of Henderson, Las Vegas, Mesquite, and North Las Vegas for the Work Zone Management – One.Network project in the amount of \$350,000.00.

RESOLUTION OF THE CITY COUNCIL OF BOULDER CITY, NEVADA, APPROVING AGREEMENT NO. 24-2085 (INTERLOCAL CONTRACT 3136) BETWEEN THE REGIONAL TRANSPORTATION COMMISSION OF SOUTHERN NEVADA AND THE CITY OF BOULDER CITY, CLARK COUNTY, AND THE CITIES OF HENDERSON, LAS VEGAS, MESQUITE, AND NORTH LAS VEGAS FOR THE WORK ZONE MANAGEMENT – ONE.NETWORK PROJECT IN THE AMOUNT OF \$350,000.00

WHEREAS, the Regional Transportation Commission of Southern Nevada (RTC) approved funding for the Work Zone Management – One.Network project; and

WHEREAS, funding for this project will come from the RTC's Highway Improvement Acquisition Fund – Fuel Revenue Indexing for Fiscal Year 2024 in the amount of \$350,000.00; and

WHEREAS, an interlocal contract is required in coordination with City of Boulder City, Clark County, and the Cities of Henderson, Las Vegas, Mesquite, and North Las Vegas for funding from the Highway Improvements Acquisition Fund to be used for the project; and

WHEREAS, this agreement was approved by the RTC on April 11th, 2024.

NOW, THEREFORE, BE IT RESOLVED that City Council approves the agreement (Interlocal Contract 3136) between the Regional Transportation Commission of Southern Nevada and the City of Boulder City, Clark County, and the Cities of Henderson, Las Vegas, Mesquite, and North Las Vegas for the Work Zone Management – One.Network project in the amount of \$350,000.00.

**INTERLOCAL CONTRACT
WORK ZONE MANAGEMENT
ONE.NETWORK**

THIS INTERLOCAL CONTRACT is made and entered into this 11TH day of April 2024, by and between Clark County, a political subdivision; the City of Las Vegas, a municipal corporation; the City of North Las Vegas, a municipal corporation; the City of Henderson, a municipal corporation; the City of Boulder City, a municipal corporation; and the City of Mesquite, a municipal corporation; hereinafter referred to individually as “ENTITY” or collectively as “ENTITIES,” and the Regional Transportation Commission of Southern Nevada, hereinafter referred to as “RTC.” The RTC and the ENTITIES are hereinafter referred to individually as “PARTY” or collectively as “PARTIES.”

W I T N E S S E T H

WHEREAS, the RTC intends to commence the construction of Work Zone Management - One.Network, hereinafter referred to as “PROJECT,” located within Clark County; and

WHEREAS, Nevada Revised Statutes (NRS) Chapter 277.180 authorizes any one or more public agencies to contract with any one or more other public agencies to perform any governmental services, activity or undertaking which any of the public agencies entering into the agreement is authorized by law to perform and refers to such as an interlocal contract; and

WHEREAS, the RTC agrees to conform to the current RTC Policies and Procedures, as amended and incorporated herein by reference; and

WHEREAS, the RTC will be the lead agency for the PROJECT; and

NOW, THEREFORE, in consideration of the covenants, conditions, agreements, and promises of the PARTIES hereto, the PARTIES agree to proceed as follows:

SECTION I: SCOPE OF PROJECT

This Interlocal Contract applies to a regional strategic plan for work zone coordination, which is an initiative that aims to improve public messaging and response in real time to construction impacts on transit and traffic management operations through Clark County. This project will focus on impacts to 80 foot and greater right-of-way roadways, which comprise the majority of RTC transit routes and signalized intersections. The RTC would like to engage in a pilot project with One.Network, which will be managed by the Freeway and Arterials Systems of Transportation (FAST). The intent of the pilot project is to increase communication and visibility related to work zones and event related traffic interruptions by implementing a system that will provide real time work zone locations and data via the One.Network platform.

SECTION II: PROJECT COSTS

The RTC agrees to provide funding for all costs associated with the PROJECT from the Regional Streets and Highways Fund as outlined below:

1. The total cost for this contract shall not exceed \$350,000.00.
2. Authorizations to Proceed (ATP) are granted as follows:
 - a. ENGINEERING not to exceed \$0.00
 - b. RIGHT-OF-WAY not to exceed \$0.00
 - c. CONSTRUCTION not to exceed \$350,000.00
3. At the time the ATP for construction is granted, the ENTITIES will make all attempts to publish the bid for this PROJECT within 90 calendar days.
4. A supplemental interlocal contract will be required for any changes to the amounts identified in number 2 above.

SECTION III: GENERAL

1. It is understood and agreed that the purpose of this Interlocal Contract is to fund the PROJECT as herein above set forth. It is further understood and agreed that the RTC is responsible for the coordination of the PROJECT. The RTC will be responsible for the actions or inactions of its Officers and Employees.
2. The PROJECT must be completed to satisfaction of the RTC prior to the current applicable completion date of June 30, 2029. The RTC may, at any time thereafter, grant time extensions or terminate this Contract.
3. The RTC disavows any responsibility for the actions or inactions of the ENTITIES, their Officers, Employees, or agents.
