Business Impact Statement:

This action will not have a significant economic impact on business and will not directly restrict the formation, operation, or expansion of a business.

Action Requested:

That the City Council approve the resolution repealing and replacing Resolution No. 7481 which had allocated \$250,000.00 of American Rescue Plan Act funding to ADA Compliance in City Hall and \$150,000.00 to a Communications Gateway and reallocating \$261,230.19 towards the Muni Court Remodel, B.C. Project No. 24-1186-MC; and approve the resolution awarding a bid to CMMCM LLC dba Muller Construction, in the amount not to exceed \$528,763.04 for the Muni Court Remodel, B.C. Project No. 24-1186-MC.

Overview:

- October 24, 2024, a Notice Inviting Bids was advertised for the project.
- November 14, 2024, 2 bids were received, opened, and tabulated.
- The Bid Summary has been attached for reference.
- Muller Construction, was the lowest bidder, with a bid of \$528,763.04.
- Funding source for this project is from the ARPA Funds.

Background Information:

As part of the American Rescue Plan Act (ARPA), funding was allocated for the Muni Court Remodel project. Work for this project will consist of alterations of various areas within the Municipal Court including demolition and construction of existing walls and facilities to achieve a new floor plan layout, electrical, plumbing, fire sprinklers and alarms, HVAC, suspended ceilings, millwork, doors, and hardware.

The Notice Inviting Bids for this project was posted to the Nevada Government eMarketplace (NGEM) on October 24, 2024. On November 14, 2024, 2 bids were received, opened, and tabulated. The Bid Summary showing the bidder's information and bid amounts has been included as an attachment to this staff report. CMMCM LLC dba Muller Construction was the lowest bidder, with a bid of \$528,763.04. Once the Notice to Proceed is issued, this will be a 90-calendar day project.

Financial:

With Resolution No. 7481, American Rescue Plan Act funding was allocated to the ADA-Compliance in City Hall project and Communications Gateway project, and staff is requesting a reallocation of \$261,230.19 from those project for the Muni Court Remodel project. Funding from the HVAC Replacement project will also be utilized towards the Muni Court Remodel project.


