SUBJECT:

For possible action: Resolution No. 7967, a resolution of the City Council of Boulder City, Nevada, declaring certain personal City property as surplus and available for disposal by public auction or other means

Business Impact Statement:

This action will not have a significant economic impact on business and will not directly restrict the formation, operation, or expansion of a business.

Action Requested:

That the City Council approve the resolution, declaring certain personal City property as surplus and available for disposal by public auction or other means.

Overview:

- Chapter 332.185 of the NRS authorizes the governing body or its authorized representative to sell personal property at public auction or other disposal, if it deems such sale or disposal desirable and in the best interest of the local government.
- Timely declaration of certain City property as surplus and available for disposal by auction or sale allows the City to receive the maximum amount of money for the items.

Background Information:

The Public Works Department has compiled a list of personal City property including vehicles and equipment that are out of date and no longer of use to the City. The list of surplus items comes from various departments. It is in the best interest of the City to dispose of these items in a fiscally responsible manner either by public auction or other

means.

RESOLUTION OF THE CITY COUNCIL OF BOULDER CITY, NEVADA, DECLARING CERTAIN PERSONAL CITY PROPERTY AS SURPLUS AND AVAILABLE FOR DISPOSAL BY PUBLIC AUCTION OR OTHER MEANS

WHEREAS, Chapter 332.185 of the NRS authorizes the governing body or its authorized representative to sell personal property at public auction or other disposal, if it deems such sale or disposal desirable and in the best interest of the local government; and

WHEREAS, various departments have identified items which are no longer being utilized by the City; and

WHEREAS, the Public Works Department has prepared the attached list of property including vehicles and equipment that are out of date or no longer of use to the City; and

WHEREAS, timely declaration of certain personal City property as surplus and available for disposal by auction, sale, or other means allows the City to receive the most money for the items.

NOW, THEREFORE, BE IT RESOLVED that City Council approves the resolution, declaring the list attached as **Exhibit A** of City Property as surplus, no longer needed for municipal purposes and available for disposal by public auction or other means; and

BE IT FURTHER RESOLVED that City Council deems disposal of surplus desirable and in the best interest of the City.
